2018/2019 SAILING INSTRUCTIONS

1 Rules

Racing at the Middle Harbour 16ft Skiff Sailing Club (the Club) will be governed by these Sailing Instructions, the Racing Rules of Sailing (RRS), the Prescriptions and Special Regulations of Sailing Australia and the rules of the Australian & New South Wales 16ft Skiff Associations. To the extent that there is an inconsistency between these rules, these Sailing Instructions prevail over the RRS, which in turn prevail over the Prescriptions and Special Regulations of Australian Sailing, which in turn prevail of the rules of the Australian & New South Wales 16ft Skiff Associations.

2 Disclaimer

- (1) All those taking part in Club racing do so at their own risk and are responsible for their own safety: see RRS 4.
- (2) The Club, its servants and agents and all parties involved with its organisation and the organisation of racing at the Club disclaim all responsibility whatsoever for any loss, damage, injury, death or inconvenience to person or goods, both ashore and at sea, as a consequence of participation in races covered by these Sailing Instructions.

3 Notices to competitors

- (1) Notices to competitors will be posted on the official notice board located inside the southern entry to the boatshed.
- (2) A briefing for competitors, race officials and support crew may be held 90 minutes before the start of the first race of the day.

4 Changes in Sailing Instructions

- (1) Any change to the Sailing Instructions will be posted on the official notice board before 1230 on the day it will take effect.
- (2) Any change to the schedule of races will be posted on the official notice board by 2000 on the day before it will take effect.

PART 1—RACING GENERALLY

5 Eligibility to race

- (1) For a boat to be eligible to race, it must be registered with the New South Wales 16ft Skiff Association, be registered with the Club, and hold a current measurement certificate that can be produced on demand.
- (2) For a sailor to be eligible to race, he or she must be a member of Sailing Australia.
- (3) For a sailor to be eligible to race more than three races, he or she must be a sailing member of the Club or have made a bona fide membership application.
- (4) Any boat that fails to submit all required documents, obtain all required registrations and make all required payments by close of business on the first day of racing shall be scored DNS for each race until all required documents have been submitted, registrations have been obtained and payments have been made.

- (5) Any change of skipper shall be notified in writing to the Race Secretary at least one hour prior to the scheduled start time of the race.
- (6) All boats must sail under the ensign registered with the New South Wales 16ft Skiff Association. Any change in ensign must be notified to the Starter in writing at least one hour prior to the scheduled start time of the race.
- (7) All boats must be checked, measured and weighed for compliance with the Class Rules by the Club Measurer. Any team with new equipment is responsible for contacting the Club Measurer and organising the measurement and certification of their equipment.
- (8) The Club Measurer may, before or after any race and on his or her own initiative, inspect any boat that he or she suspects is not compliant with the Class Rules.
- (9) For permission to use equipment that does not comply with the Class Rules, an application must be made in writing to the Race Secretary and put to a vote of the sailors at a sailing meeting or at a briefing on the race day.

6 Signals made ashore

- (1) Signals made ashore will be displayed on the Club flagpole, which is located on the northeastern corner of the upper deck, or if the flagpole cannot be accessed, from the committee boat anchored in front of the clubhouse.
- (2) When the AP is displayed ashore, the warning signal will be made not less than 60 minutes after AP is lowered. This amends Race Signal 'AP'.

7 Schedule of races

- (1) Races are scheduled as per the calendar published on the Club website and displayed on the official notice board.
- (2) Outside of daylight savings:
 - (a) No warning signal for a race (other than a Sprint Series race) shall be made after 1530.
 - (b) No warning signal for a Sprint Series race shall be made after 1615.
- (3) During daylight savings:
 - (a) No warning signal for a race (other than a Sprint Series race) shall be made after 1600.
 - (b) No warning signal for a Sprint Series race shall be made after 1645.

8 The racing area and courses

- (1) The Starter shall set the course for each race in accordance with sections 19 to 22 of these sailing instructions.
- (2) No later than the warning signal, a board indicating the official course to be sailed will be displayed on the committee boat, unless the race is scheduled to be held on a compass-bearing course, in which case a board indicating the compass bearing and a numeral flag indicating the number of times to the windward mark will be displayed on the committee boat.
- (3) Where the course is a gated compass-bearing course, boats are not required to pass through the gate on the final downwind leg to the finish.

9 Class flags

- (1) The 16ft Skiff class flag is a black '16' displayed on a white background.
- (2) The 13ft Skiff class flag is the 13ft Skiff logo displayed on a white background.

10 Marks

- (1) The rounding marks are large yellow conical inflatables with MH16SC printed in black, except where indicated on the course maps.
- (2) The committee and support boats shall fly the Club burgee.
- (3) The change of course mark is a large yellow cylindrical inflatable with a black band.

11 The start

- (1) The start line shall be between a staff displaying an orange flag on the committee boat at the starboard end and a mark displaying an orange flag on the port end.
- (2) A boat seen in the vicinity of the starting line after the warning signal will be counted as a starter even if it does not actually start. This amends RRS Appendix A4.
- (3) A boat not seen in the vicinity of the start line after the warning signal and attempting to start later than 10 minutes after her starting signal will be scored DNS. This amends RRS Appendix A4.
- (4) A boat whose warning signal has not been made shall avoid the starting area during the start sequence for other races.
- (5) All races shall have a five-minute start sequence, except for the races in the Sprint Series, which shall have a three-minute start sequence: see section 21(5).
- (6) Races in the Crews Trophy shall have a handicap start: see section 20(2).
- (7) The start sequence shall include the following signals:

Signal	Flag and sound	Minutes (standard)	Minutes (Sprint Series)
Warning signal	Class flag and 1 sound	5	3
Preparatory signal	P Flag, I Flag, U Flag, Z Flag or Black Flag and 1 sound	4	2
One-minute signal	Preparatory flag removed and 1 long sound	1	1
Starting signal	Class flag removed and 1 sound	0	0

12 The finish

- (1) For a non-gated course, boats shall sail upwind through the finishing line, which shall be between a staff displaying an orange flag on the committee boat at the starboard end and a mark displaying an orange flag on the port end.
- (2) For a gated course, boats shall sail downwind through the finishing line, which shall be between a staff displaying an orange flag on the committee boat at the

port end and a mark displaying an orange flag at the starboard end, and are permitted to sail under spinnaker whilst doing so.

- (3) The committee boat will display a blue flag when it is on the finishing line.

13 Individual recall

- (1) In addition to RRS 29.1, at the first windward mark after the start, a committee boat may display an OCS board identifying any boats that scored OCS. A sound signal may be used to draw attention to the board.
- (2) If the preparatory signal was a P Flag, any boat identified as OCS on the board may sail clear from the fleet and complete a 1800° turn (five circles) to clear itself of any penalty.
- (3) If the preparatory signal was not a P Flag, any boat identified as OCS on the board shall be scored OCS.

14 Change of course after the start

- (1) The Starter may shorten the course for any of the reasons included in RRS 32 but may also shorten the course if he or she is of the opinion that the majority of the fleet will not finish in the time limit.
- (2) A change of course after the start shall be signalled in accordance with RRS 33 before the leading boat has begun the leg, although the new mark may not then be in position. Any mark to be rounded after rounding the new mark may be relocated to maintain the original course configuration. When in a subsequent change of course a new mark is replaced, it will be replaced with a mark of the characteristics of the original mark.

15 Safety requirements

- (1) Notwithstanding that sailors are responsible for their own safety in accordance with the disclaimer in section 3:
 - (a) All sailors shall comply with Specific Regulation R1 (Personal Buoyancy) by wearing, whilst afloat, an approved personal flotation device.
 - (b) Any boat that retires from a race must notify the Starter as soon as possible, either on course or by contacting them immediately upon arriving ashore.

16 Scoring generally

- (1) The Low Point System and other relevant provisions of the RRS Appendix A shall apply, except that a boat that scores DNC will be awarded points equal to the number of boats that are registered with the Club on the date of the race plus two (2) places. This amends RRS A9.
- (2) Average points:
 - (a) Any boat that represents the Club in the New South Wales State 16ft Skiff Championships or an inter-club regatta sanctioned by the New South Wales 16ft Skiff Association shall be awarded average points for, and be deemed to have sailed in, any race conducted by the Club on the same day as that Championship or regatta.

- (b) Average points shall be calculated using the average score of the boat in the last three consecutive Point Score races sailed prior to the Championship or regatta, unless three consecutive Point Score races have not been completed, in which case average points shall be calculated using the average score of the boat in the three Point Score races closest to the Championship or regatta, either before or after the Championship or regatta but only including results from the 2018/2019 sailing season.

17 Protests

- (1) Any boat wishing to protest against another for an incident in the racing area shall conspicuously display a red flag at the first reasonable opportunity and continue to display it until it is no longer racing: this amends RRS 61.1(a)(2).
- (2) Protests shall be made in writing and submitted to the Starter within 60 minutes after the time of the last finish time of the last boat: this amends RRS 61.3.
- (3) The Protest Committee elected at the preceding Annual General Sailing Meeting shall hear all protests. If a member of the Protest Committee has a vested interest in the protest, the Starter shall take the place of that member, or nominate a suitable disinterested person to take the place of that member.
- (4) As required by RRS 63.2, protest notices will be posted on the official notice board within 30 minutes of the protest time limit to inform competitors of the time and location of a protest hearing to which they are parties or in which they named as witnesses. The posting of such notice is notification to all parties for the purpose of RRS 63.2.
- (5) The “authority” for the purposes of RRS 64.3(b) is the Club Measurer.

PART 2—TYPES OF RACES

18 The racing program

- (1) The racing programme shall include four types of races:
 - (a) Club Championship races.
 - (b) Crews Trophy races.
 - (c) Sprint Series races.
 - (d) Other races.
- (2) Instructions and scoring for each type of race are set out in sections 19 to 22.

19 The Club Championship

- (1) Each race in the Club Championship shall be sailed on the official courses available on the Club website, unless the Starter deems it unsafe to sail on the official courses, in which case the Starter may set a different course, provided that he or she gives the sailors notice of the change at least 90 minutes prior to the scheduled start time.
- (2) The time limit for each race shall be 3 hours from the last starting signal, or 45 minutes from the finishing time of the first boat, whichever is shorter. A boat

that fails to finish within the time limit shall be scored DNF. This changes RRS 35 and Appendix A4.

- (3) Each race of the Club Championship shall have a scratch start.
- (4) Scoring:
 - (a) Seven races are scheduled for the series.
 - (b) Five races are required to be competed to constitute a series.
 - (c) If six or more races are completed, the overall score of each boat will be the total of its race scores minus its worst score.
 - (d) Points are awarded based on the scratch results.

20 The Crews Trophy

- (1) Each race in the Crews Trophy shall be sailed on the official courses available on the Club website, unless the Starter deems it unsafe to sail on the official courses, in which case the Starter may set a different course, provided that he or she gives the sailors notice of the change at least 90 minutes prior to the scheduled start time.
- (2) The start for a Crews Trophy race shall be as follows.
 - (a) At one minute before the start, the preparatory flag shall be lowered and an electronic numerical board displaying the time one minute greater than the handicap of the boat with the highest handicap shall start counting down.
 - (b) When the electronic numerical board reaches the time of the handicap of the boat with the highest handicap, the class flag shall be lowered.
 - (c) Each boat shall start when its handicap time is displayed on the electronic numerical board (ie a boat with a five-minute handicap shall start when the board displays 5:00).
- (3) The time limit for each race shall be 3 hours from the last starting signal, or 45 minutes from the finishing time of the first boat, whichever is shorter. A boat that fails to finish within the time limit shall be scored DNF. This changes RRS 35 and Appendix A4.
- (1) Scoring:
 - (a) Seven races are scheduled for the series.
 - (b) Five races are required to be competed to constitute a series.
 - (c) If six or more races are completed, the overall score of each boat will be the total of its race scores minus its worst score.
 - (d) Points are awarded based on the handicap results.

21 The Sprint Series

- (1) Each race in the Sprint Series shall be two laps of a gated compass-bearing course as depicted in Addendum A to these sailing instructions. The course shall be set in the Sound, unless the Starter deems it unsafe to sail in the Sound, in which case the Starter may set a different course, provided that he or she gives the sailors notice of the change at least 90 minutes prior to the scheduled start time.
- (2) The Starter shall set the length of the course as is necessary for the first boat to finish approximately 25 minutes after starting.

- (3) The time limit for each race shall be 5 minutes from the finishing time of the first boat.
- (4) A boat that fails to finish within the time limit shall be scored DNF. This changes RRS 35 and Appendix A4.
- (5) Each race in the Sprint Series shall have a three-minute start sequence. The warning signal for the second, third and fourth race on any day shall not be sounded until six minutes after the finishing time of the first boat, or one minute after the finishing time of the last boat, whichever is earlier.
- (6) Each race of the Sprint Series shall have a scratch start.
- (7) Scoring:
 - (a) Twelve races to be raced over four days are scheduled for the series.
 - (b) Nine races are required to be completed to constitute a series.
 - (c) If Nine or more races are completed, the overall score of each boat will be the total of its scores minus its worst score.
 - (d) Points are awarded based on the scratch results.

22 Other races

- (1) Any race that is not a Club Championship, Crews Trophy or Sprint Series race shall be 6 to 8 laps of a gated compass-bearing course as depicted in Addendum A to these sailing instructions. The course shall be set in the Sound, unless the Starter deems it unsafe to sail in the Sound, in which case the Starter may set a different course, provided that he or she gives the sailors notice of the change at least 90 minutes prior to the scheduled start time.
- (2) The Starter shall set the length of the course and the number of laps as is necessary for the first boat to finish approximately 100 minutes after starting.
- (3) Each race shall have a scratch start.
- (4) The time limit for each race shall be 3 hours from the last starting signal, or 45 minutes from the finishing time of the first boat, whichever is shorter. A boat that fails to finish within the time limit shall be scored DNF. This changes RRS 35 and Appendix A4.

PART 3—THE ANNUAL POINT SCORE

23 The Annual Point Score

- (1) Points in the Annual Point Score are awarded based on the handicap results from each Club Championship race, each Crews Trophy race, and any other race delegated by the Calendar to be a Point Score race.
- (2) Twelve races are required to be completed to constitute a series.
- (3) If twelve to seventeen races have been completed, the overall score of each boat will be the total of its race scores minus its worst score.
- (4) If eighteen or more races have been completed, the overall score of each boat will be the total of its race scores minus its worst two scores.

24 First Half Annual Point Score

- (1) The first half of the Annual Point Score shall comprise races 1 to 10.
- (2) Six races are required to be completed to constitute a series.

- (3) If six to ten races are completed, the overall score of each boat will be the total of its race scores minus its worst score.

25 Second Half Annual Point Score

- (1) The second half of the Annual Point Score shall comprise races 11-20.
- (2) Six races are required to be completed to constitute a series.
- (3) If six to ten races are completed, the overall score of each boat will be the total of its race scores minus its worst score.

PART 4—HANDICAPPING

26 Handicap rules

The handicaps shall be adjusted from week to week according to the Handicap Rules set out in Addendum B to these sailing instructions.

PART 5—PRIZES AND PRIZE MONEY

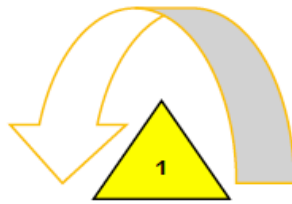
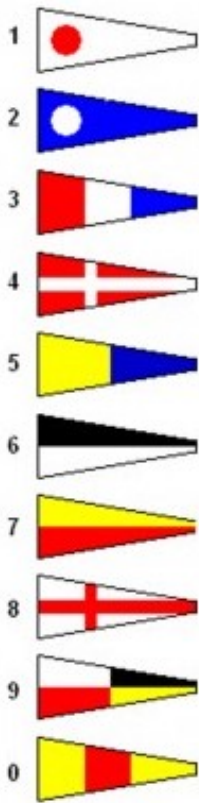
27 Eligibility for trophies and prize money

- (1) To be eligible to win the Club Championship, a boat must have sailed in 70% of Point Score races.
- (2) To be eligible to receive full payment of prize money, a boat must be represented by at least one member of its regular crew for at least five of the seven scheduled sailing meetings.
- (3) Any boat represented in less than five of the seven scheduled sailing meetings shall receive prize money in accordance with the following table.

Meetings attended	Percentage of prize money payable
5-7	100%
4	90%
3	80%
2	70%
1	60%
0	50%

- (4) Any prize money not paid due to section 27(3) shall be returned to the total prize money pool and redistributed among the other boats according to the results of the season.

ADDENDUM A—GATED COMPASS-BEARING COURSE

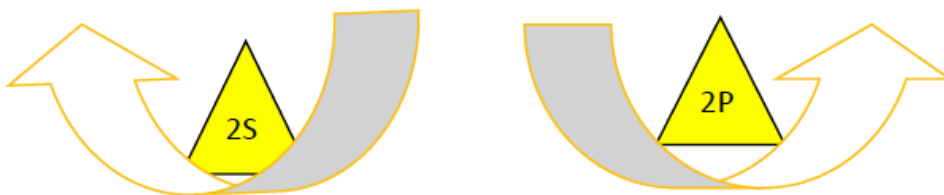


NUMERAL

ADDENDUM B—HANDICAP RULES

- Rule 1** The handicap of the skipper who comes first on handicap in a Point Score race shall be decreased by three minutes in the next Point Score race.
- Rule 2** The handicap of the skipper who comes second on handicap in a Point Score race shall be decreased by two minutes in the next Point Score race.
- Rule 3** The handicap of the skipper who comes third on handicap in a Point Score race shall be decreased by one minute in the next Point Score race.
- Rule 4** The handicap of any skipper who comes fourth on handicap in two Point Score races in a row shall be decreased by one minute in the next Point Score race.
- Rule 5** The maximum handicap of any skipper shall be 30 minutes.
- Rule 6** If by reason of Rules 1-4 the handicap of a skipper when adjusted will be less than zero, the handicap of that skipper shall be zero, and the handicap of every other skipper who started the race shall be increased by the number of minutes that the skipper adjusted to zero would have been below zero but for this rule.
- Rule 7** For any Point Score race in which the skipper with the lowest handicap does not start because he or she is attending an interclub regatta, the skipper with the next lowest handicap shall be treated as if their handicap is zero, and the handicap of every other skipper shall be adjusted accordingly.
- Rule 8** Any skipper who has finished less than three Point Score races in a 16ft Skiff at the Club shall have a handicap of zero.
- Rule 9** For any race in which there is a handicap start, the starter may determine the starting time of a skipper whose handicap is zero due to Rule 8, provided that the results of the race are adjusted to reflect their handicap of zero.
- Rule 10** When a skipper referred to in Rule 8 has finished three Point Score races, the Race Secretary shall calculate their handicap by comparing their results in those three races to the results of three other skippers.

- Rule 11** If a skipper referred to in Rule 8 has started but not finished three Point Score races, the Handicap Committee may determine her or his handicap judging her or his performance in the three races.
- Rule 12** The Race Secretary is responsible for the adjustment of the handicaps.
- Rule 13** The Race Secretary shall adjust the handicaps in accordance with these Rules and these Rules only.
- Rule 14** A skipper may appeal a decision of the Race Secretary to the Handicap Committee. The Handicap Committee shall determine the appeal in accordance with these Rules and these Rules only.
- Rule 15** A skipper may apply to the Handicap Committee for a revision of their handicap. The application must be sent by email to the Race Secretary at least three days before the race in which the handicap adjustment is sought and must set out the grounds upon which the revision is requested.
- Rule 16** These Rules may be amended only by a majority vote at the Annual General Sailing Meeting.
